I AGREE (PLEASE READ CAREFULLY):

- 1. To provide proper and adequate food, water, and humane treatment at all times.
- 2. To provide accessible housing that offers protection from the weather.
- 3. To provide veterinary care to prevent or cure illness.
- 4. To keep the animal current on vaccinations.
- 5. To have the animal spayed or neutered at my expense if animal is still intact.
- 6. To obey state and local laws regarding animals.
- 7. That the dog will have a current City of Petersburg license (living within city limits).
- 8. That the animal will not be unattended or running at large.
- 9. That the animal will not be reported as objectionable (barking, chasing cars, etc.)
- 10. That if two impounds occur within one year, PHA reserves the right to repossess this animal.
- 11. Not to sell, give away, or abandon this animal if I no longer want it, but to return it to PHA.
- 12. To allow a PHA representative to examine the animal and its living conditions and to return the animal if these conditions are not satisfactory.
- 13. That PHA is not responsible for any damages incurred while the animal is in my possession.

I have read and understand the Conditions of Adoption. If any violations of these conditions occur within six months after the adoption is final, PHA reserves the right of repossession.
